

ORDER NO. 23/2024

OF THE RECTOR OF THE UNIVERSITY OF SZCZECIN

of 12 August 2024

on lustration declarations of candidates to take up the post of and employment as Directors of Institutes

Pursuant to Article 23(1) of the Act of 20 July 2018 Law on higher education and science (Dz.U. (Journal of Laws) of 2023 item 742 as amended, it is agreed as follows:

§ 1.

1. Pursuant to Article 7(1) and (2) of the Law of 18 October 2006 on disclosing information on documents of state security authorities from 1944-1990 and content of these documents (Dz. U. (Journal of Laws) of 2024 item 273), hereinafter referred to as “Law”, a person applying to hold public functions, born before 1 August 1972, upon giving their consent to be a candidate and upon their consent to take up or perform the function shall be obliged to submit to a competent authority a declaration on their work or service in state security authorities or on their collaboration with such authorities in the period from 22 July 1944 to 31 July 1990, hereinafter referred to as “lustration declaration”.
2. Pursuant to Article 4(44)(b) of the Law, the obligation to submit a lustration declaration shall apply to candidates for taking up the post of and employment as a Director of an Institute.
3. The declaration or information about submitting the declaration shall be submitted without the Rector’s call upon expressing their consent to be a candidate or consent to take up or perform the function or the post, by submitting a filled out form as laid down in the specimen that is an annex to this Order. Should the candidate have submitted a lustration declaration already, they shall provide information about having already submitted such a declaration (Article 7(3a) of the Law). Each time a candidate expresses their consent to be a candidate or their consent to take up or perform a public function, they shall submit a relevant document, even if they are re-applying for the same function.
4. A filled out and signed lustration declaration or information about having submitted the lustration declaration must be submitted in a sealed envelope, with hand-written writing on it, addressed to the Rector of the University of Szczecin and include the following information:
  - 1) candidate’s first and last name;
  - 2) a note “lustration declaration” or “information about having submitted a lustration declaration”;
  - 3) date of submission of the declaration.
5. The sealed envelope with the declaration or information shall be delivered to the Office of the Rector of the University of Szczecin to room 23 in person or shall be sent in a larger envelope through the General Office of the University of Szczecin or by registered post

to: al. Papieża Jana Pawła II 22a, 70-453 Szczecin with a note “Biuro Rektora, p. Aneta Zygmunt do rąk własnych” before the final deadline of 5 November 2024.

§ 2.

The Order shall enter into force on the date it is signed.
